

Attendees of the September 19, 2015 St. Louis-Area Disciples Summit on Racial Justice:

I've not necessarily ordered them in any way, but here are some things I've been reading and viewing lately as I think about racism and white privilege. The list, of course, is partial. There are thousands of resources – films, websites, seminar papers, books, chapters, articles, comic strips, podcasts, and conversations – that can help and challenge us as we work for greater justice and understanding.

It's astounding that we are covering much of the same ground over and over again. There are strong systemic reasons that transformation is slow and painful. Many of the resources below have been helpful and challenging to me. Some are older. Some are newer. Some are more academic, some more narrative and personal/confessional in style. Some of these resources look at specific sectors and experiences. All of them, it seems to me, tell pieces of the same story – systemic white supremacy in the United States. This is a story that's hard to hear and difficult to comprehend because it's pervasive, and people of all races have internalized many of its manifestations.

As I was reading the item I've placed first on the list below (Ferguson Commission Report 2015), I was struck by how much it reminded me of the second item on this list (U.S. Riot Commission Report 1967/68). Perhaps I need not have been surprised. The Introduction to the report from the 1960s concludes thusly:

One of the first witnesses to be invited to appear before this Commission was Dr. Kenneth B. Clark, a distinguished and perceptive scholar. Referring to the reports of earlier riot commissions, he said:

I read that report...of the 1919 riot in Chicago, and it is as if I were reading the report of the investigating committee on the Harlem riot of '35, the report of the investigating committee on the Harlem riot of '43, the report of the McCone Commission of the Watts riot.

I must again in candor say to you members of this Commission – it is a kind of Alice in Wonderland – with the same moving picture re-shown over and over again, the same analysis, the same recommendations, and the same inaction.

These words come to our minds as we conclude this report. We have provided an honest beginning. We have learned much. But we have uncovered no startling truths, no unique insights, no simple solutions. The destruction and the bitterness of racial disorder, the harsh polemics of black revolt and white repression have been seen and heard before in this country.

It is time now to end the destruction and the violence, not only in the streets of the ghetto but in the lives of people. (p. 29)
