CONCERNING CHRISTIAN CHURCH (DISCIPLES OF CHRIST) CONGREGATIONS RECEIVING A SILVER CHALICE DESIGNATION (Sense-of-the-Assembly)

GA-2512

WHEREAS, the mission of the Christian Church (Disciples of Christ) is "to be and to share the good news of Jesus Christ witnessing, loving, and serving from our doorsteps to the ends of the earth." This mission is for all people and all generations…not just those who are young and able-bodied; and

WHEREAS, the scriptures underscore how a person's advanced age is equated with honor and respect– including the years of Adam, Seth, Enoch, Noah, Abraham, Sarah, Methuselah, Joseph, Moses, Joshua, Job, Elizabeth, Simeon, and Anna;¹ and

WHEREAS, older adults (referring loosely to those 65 and older) have much to contribute to the life of the church. Not only do many of them hold the historical knowledge and experience of being the Church, but they have many talents and gifts that may be mistakenly overlooked or minimized due to their age; and

WHEREAS, the richness of wisdom and knowing from Disciples Older Adults include retired clergy, retired clergy spouses, and lay leaders; and

WHEREAS, since its beginning, the National Benevolent Association of the Christian Church (Disciples of Christ) (NBA) has played a significant role in creating and sustaining ministries of care for older adults, to include senior housing facilities, senior community centers, supporting chaplains serving older adults, and supporting congregational care of older adults. In more recent years, the NBA has carried forward this in efforts such as the West Virginia's Gift of Years Program, funds or the expansion of Mid-America Region's Older Adult ministries, and through grant funding for older adult ministries across the church including congregational projects and initiatives of health and social service organizations such as Kansas Christian Homes, Christian Care Communities of Kentucky, and Juliette Fowler. NBA now seeks to further amplify this work and the leaders who have given shape to it through a 2-year Older Adult Ministries (OAM) initiative. The purpose of the Silver Chalce Ministry is to encourage, support, and celebrate Disciples of Christ congregations, general ministries, assemblies, gatherings, organizations, regions and facilities (hereafter collectively referred to as Ministry) who have a strong desire to live out their Christian faith by caring for, assisting and utilizing the gifts of wisdom of older adults; and

WHEREAS, earning a Silver Chalice designation means a Ministry has reached established goals regarding programming and services that focus on adding meaning and values to the lives of older adults as well the life of the larger Church; and

WHEREAS, a growing church identifies opportunities to utilize the gifts of older adults and helps identify unmet needs of older adults within the Church as well as the community at large and offers resources to help meet those needs; and

WHEREAS, many older adults in our congregations are currently suffering from discrimination in the public sphere, linguistic and employment discrimination, lack of access, isolation, neglect, financial exploitation, physical and psychological violence and the withholding of basic needs, among other injustices; and

WHEREAS, the issue of violence and abuse is considered a priority of the Independent Expert on the enjoyment of all human rights by older persons, (a position mandated by the UN Human Rights Council Resolution 33/5 to investigate, monitor, and recommend solutions to human rights violations against older persons). This issue is consistently addressed in thematic reports in the United Nations and several other international organizations.² We are called to be responsive and act; and

WHEREAS, instead of lamenting how the church is dying (physically and spiritually), we include the amazing resource of our older adults in "witnessing, loving, and serving" our communities as we continue to find ways to bring hope to this "fragmented world." We seek to better engage the older adults in our communities and to help older adults grow in their faith: and

THEREFORE, BE IT RESOLVED that congregations and regions implement the necessary steps to live into our Silver Chalice Covenant to lift up ministry to, for, and with older adults.

BE IT FURTHER RESOLVED that the General Assembly encourage the starting of more intergenerational programs where children and teens interact with older adults in meaningful and joy-filled ways.

BE IT FURTHER RESOLVED that Disciples seek to serve those in our congregations and communities living with dementia as well as possible and to have more resources for caregivers and support groups.

BE IT FURTHER RESOLVED that Silver Chalice offers two levels to indicate a congregation's/organization's commitment to older adults. Silver Chalice congregations/organizations will have access to a designated Silver Chalice Mentor to

walk through the process, to encourage brainstorming and to implement what would work best for the setting and connect to available resources.
